Hillary Critcher, 18 Muxton Lane, Muxton, Telford, Shropshire,  
Erection of two storey side extension and replacement double garage  
**Resolved** – to have no objection to this application.
- b. TWC/2018/0183  
Mr and Mrs Butler, 61 Muxton Lane, Muxton, Telford, Shropshire  
Removal of existing rear conservatory and the erection of a two storey front and side extension.  
**Resolved** – to have no objection to this application.
- c. TWC/2018/0186  
Michael Fisher, 10 Millers Way, Muxton, Telford, Shropshire.  
Erection of a single storey front and side extension and re-siting of shed.  
**Resolved** – to object to this application for the following reasons:  
Loss of Parking Spaces – the property shares a driveway with its neighbour where there are allocated parking spaces next to the houses. This application would remove the parking space at this site and also make it virtually impossible for the neighbour to use their parking space as the proposed extension would have an adverse effect on the ability of the neighbour to open their car door as they share adjoining driveways.  
Loss of neighbours amenities – the proposed side extension would block open access to the rear of No.10 and prevent reasonable access for the neighbour to access the rear of their property.

Overdevelopment of site – the proposed extension would also constitute an over-development of site and have an adverse impact on the adjoining neighbours property including loss of light.
