<u>Donnington and Muxton Parish Council</u> <u>Minutes of the Annual Council Meeting held at Turreff Hall</u> on 14th May 2018

18/05/01 Chair of the Council:

18/05/05 Environmental Officer Telford & Wrekin Council

The Chairman welcomed Kay Grice, the recently appointed Environmental Locality Office for this area of Telford. Mrs Grice informed Councillors that her role was to oversee the environment for this parish and her area covered the eastern area from Newport to Randlay. Councillors can contact her via the Clerk or directly and she is willing to undertake a walk around the various Wards should this be required. When asked, Mrs Grice replied that: dog fouling and dog control would be the responsibility of Telford & Wrekin Council's Environmental Crime Team; fencing for a specific dog area on Broadoaks Field would cost approximately £60 per metre depending on what type of fencing is required; the Borough Council is currently carrying out a survey of all bins in Telford to identify ones which are not used and these will be re-located to areas requiring them and; grass cutting is behind schedule at the moment due to the recent inclement weather.

Councillors suggested that Telford & Wrekin Council does more to publicise successful prosecutions regarding dog fouling and fly tipping as well as highlighting issues via social media and make call centre numbers more visible. Councillor A Lawrence asked if it would be possible to get the fencing around the play area at Chiswick Court/Bloomsbury Court re-painted.

The Chairman thanked Mrs Grice for attending the meeting.

17/05/22 General Power of Competence

The three conditions for eligibility for the Parish Council to exercise the General Power of Competence are as follows:

Resolution: The Council must resolve at a meeting that it meets the criteria for eligibility relating to the electoral mandate and relevant training of the Clerk.

Electoral Mandate: at the time the resolution is passed, at least two-thirds of the council must hold office as a result of being declared elected (i.e. not co-opted).

Qualified Clerk: at the time that the resolution is passed, the Clerk must hold a recognised professional qualification (e.g. Certificate in Local Council Administration, Certificate of Higher Education in Local Policy) **AND** pass the 2012 CiLCA module relating to the general power of competence.

Resolved – as a result of satisfying the above criteria the Parish Council, from 14th May 2018 until the next relevant Annual Meeting of the Council, that having met the conditions of eligibility as defined in the Localism Act 2011 and SI 965 The Parish Councils (General Power of Competence)(Prescribed Conditions) Order 2012, adopts the General Power of Competence.

18/05/23 Gateway Signs

Councillors discussed which locations would be best to install the Gateway Signs. **Resolved** – that a Gateway sign is installed at the following locations:

- a. Station Road, The Humbers near to the junction with Clocktower Roundabout.
- b. St George's Road, Donnington near to the junction with Wrockwardine Wood Way and Asda Donnington.
- c. Wellington Road, Trench near to the junction with Furnace Lane and Territorial Army (TA) Centre.
- d. Wellington Road, Muxton in the proximity of Entry Bank coming from Honnington Grange/Lilleshall.
- e. School Road, Donnington opposite McDonalds before the junction with Kingsley Drive.

18/05/24 Bollards and traffic calming measures

Councillors considered the installation of bollards outside, or adjacent too, local schools to prevent vehicles parking on grassed areas and to consider what other traffic calming measures could be installed.

Resolved – to contact Kay Grice, who had earlier left the meeting, to quote for the installation of the bollards at Thornton Park Avenue, Muxton and request that Telford & Wrekin Council repairs the speed humps outside Muxton Primary School. The Clerk was also asked to investigate the cost implications of additional signage outside local schools and if the Borough Council would finance these.

18/05/25 Telford@50

The Clerk informed Councillors of the responsibilities of the Parish Council requested by Music for the People for the proposed music festival. The Clerk also informed Councillors that he had provided dates on which to meet with representatives from Music for the People but, as yet, had received no response. Councillors were concerned of the lack of information regarding the event and lack of funding. The Parish Council would not be responsible for financing the whole event.

Resolved – that due to the unknown liabilities and proposed responsibilities this Council no longer supports the proposed music festival to celebrate Telford@50.

18/05/26 End of World War 1 Commemoration

Councillors discussed commemorating the end of World War 1.

Resolved – that this Council re-dedicates the Memorial Gates at Donnington Recreation Ground with refreshments to be provided at either Cordingley Hall or Turreff Hall after the event. A date for this event is yet to be finalized.

18/05/27 Christmas Festival 2018

Councillors discussed the Christmas Festival 2018.

Resolved – that the Clerk re-schedules the working group meeting to discuss and organise the Christmas Festival and investigate who now owns The Parade, Donnington.

18/05/28 Grant Application

Councillors discussed a grant application received by this Parish Council from Laura Deighton Dance Company.

Resolved – that under the General Power of Competence a grant of £300 is awarded to Laura Deighton Dance Company.
